OUR LEGACY

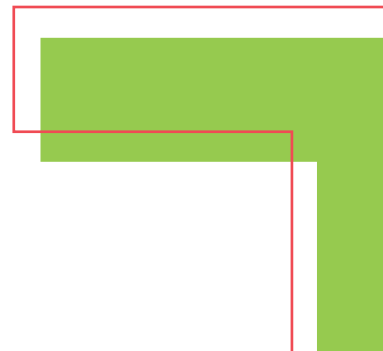
As one of the first trading companies in Mauritius, Harel Mallac has contributed to the growing Mauritian economy while pioneering major sectors such as retail, fertilisers and technology.

The company's activities story began in 1789, when Charles-Pierre Harel, from Saint-Malo, Brittany, France, was authorised by the Governor of Isle de France to charter merchant ships from Port-Louis. On the other side, the Mallac family started their business activities in 1830 with a company bearing the name 'P. Elias and Tristan Mallac', which later became 'P. Elias, Mallac et Compagnie'. In 1920, the two sides merged into 'Harel Mallac & Co'.

Initially located at La Chaussée, in the heart of Port-Louis, the company had specialised in commerce, and insurance, while also supplying loans to local planters. Following the destruction of its premises by a fire in 1893, Harel Mallac & Co. moved its offices to Rempart Street, now known as Edith Cavell Street.

Incorporated in 1956, Harel Mallac & Co. has helped buttress strategic Mauritian industries by supplying high-quality products, services and expertise, which would contribute to bettering their performance. The vision and audacity of its leaders helped give our country a more prominent role on the world stage, whilst providing new opportunities to better the lives of Mauritians.

Listed on the Stock Exchange of Mauritius since 1991, Harel Mallac stands today as a key conglomerate that remains true to the spirit of its "purpose" : to Make a Difference for the Better.
